Here's what you need to know about filing a Notice of Appeal:



1 Know your appeal deadline

- You may appeal your property's assessment or the outcome of your Request for Reconsideration to the Georgina Island First Nation Assessment Review Board (GIFN ARB) within 105 days from the date the Property Assessment Notice was mailed or emailed
- The appeal deadline can be found on your Property Assessment Notice



Submit your appeal

Submit your appeal in person or by mail to MPAC, 100 Via Renzo Drive, Suite 302, Richmond Hill, Ontario, L4S 0B8. Please remember to include the following:

- Completed Notice of Appeal
- Copy of your Property Assessment Notice
- A cheque, money order or bank draft, payable to the Chippewas of Georgina Island First Nation in the amount of \$30

Frequently Asked Questions

What does the GIFN ARB do?

The GIFN ARB will listen and determine the assessment outcome based on evidence brought forward at your hearing.

What does MPAC do?

MPAC is contracted by the Chippewas of Georgina Island First Nation to provide property assessments on Georgina, Snake and Fox Islands, in accordance with GIFN property taxation and assessment laws. MPAC will respond to assessment appeals related to valuation, classification, errors or omissions in the assessment or Property Assessment Notice.

Can the GIFN ARB lower my property taxes?

No, the GIFN ARB can only confirm or reduce your assessment which may result in lower property taxes. GIFN is responsible for setting your tax rate and collecting property taxes. Is the administration fee refundable?

The administration fee is not refundable.

Who bears the burden of proof in an appeal?

The burden of proof in an appeal is on the person bringing the appeal.
